## **India's Commitment to Clean Energy**

#### COP-26: 2021

India set a net-zero Emissions target for 2070, highlighting its commitment to cleaner energy and reduced import dependence. Considering the alarming effects of Global Warming, over 190 countries have come together to announce their Net Zero Targets.

### **Natural Gas in Energy Mix**

The government aims to boost the share of Natural Gas in the primary energy mix from 6% to 15% by 2030. Natural Gas is the cleanest fuel with the lowest GHG emissions and is considered as the transition fuel.

Therefore, by increasing the consumption share of NG in India's energy mix, industries can lower their GHG emissions.

#### **GAIL's Initiative**

GAIL developed a Net-Zero Emissions target in FY 2022-23 and further accelerated its decarbonization goals, by advancing its Net Zero Emissions target for 100% reduction in Scope-1 & 2 emissions from Year 2040 to 2035.





### **GAIL's SCOPE-1 & 2 Emissions**



GAIL has set its ambitious Net Zero target for 100% reduction in Scope-1 & 2 emissions by 2035 and 35% reduction in Scope-3 emissions by 2040.

Projections made considering no interventions by GAIL to curb Scope-1 & 2 emissions.


#### **Avoidance Scenario**

MntCO2e by 2028. New Expansion Projects to be preferably 'Net Zero by Design'.


#### **Net Zero Emission Scenario**

The desired scenario, accounting for all decarbonization levers to gradually reduce emissions to "Zero".
























### **Renewable Energy**

Additionally, MoU has also been signed with the Government of Karnataka to establish 01 GW of Renewable Energy capacity in the state.




# Green Hydrogen Pilot Plant at Vijaipur, M.P.



GAIL has set-up India's 1st **10 MW PEM based Electrolyser** at Vijaipur, Madhya Pradesh to produce **4.3 TPD** of Green Hydrogen.

The plant was inaugurated by **Shri. Pankaj Jain, Hon'ble Secretary, MoPNG** on 24<sup>th</sup> May 2024.









## 'Gas Turbines to Electric Drives' at Vijaipur, M.P.



GAIL Vijaipur has successfully completed the 1st pilot project of replacing "Gas Turbine to Electric Motor". A Siemens make 3.6 MW Motor has replaced the Allison (now Siemens) make 4.1 MW (ISO) Gas Turbine. This will lead to reduction of CO2 emission ~ 6500 TPA.







# **Compressed Biogas Plant**



GAIL has set up **05 TPD CBG Plant** at Ranchi, Jharkhand to process 150 TPD of Municipal Solid Waste (MSW).

The plant was inaugurated on 2<sup>nd</sup> October 2024 by Hon'ble PM Shri Narendra Modi.

GAIL further plans to install total **26 CBG Plants** by the year 2030.
